With the start of the new academic year the Pro Bono Program is pleased to announce two new projects with the 5th Circuit Public Defender's Office.

The *Homeless Court Case Preparation Project* allows students to take the lead on case preparation for clients at the Columbia Homeless Court. This holistic court meets once a month and provides clients with a fresh start but before the court can rule, they must have evidence of good faith and improvement.

The *5th Circuit Public Defender Special Research Project* involves a team of law students researching and collecting the various resources on a particular topic; putting it into a usable and logical format and finally explaining the next steps a client would take. Topics range from expungement, family law, §8 housing and more. Create your own team or join one.
